

Twin Valley Alliance Church has started van transportation for children who would like to attend Sunday School and Church. All of the following pages will need to be completed and sent back and received by me before any child is picked up. I will let you know, by your notification of choice, when your child will be able to be picked up.

The van should start picking children up at 8:00am. Please be ready so there is very little delay in picking up other children. Your children will attend Sunday school starting at 9:00am and then church at 10:00.

Children will be assigned an adult helper to assist them through Sunday School and Church. During Church, depending on the age, children will be able to attend either Kingdom Kids (ages PreK-K), Children's Church (grades 1-4), or the Pre-teen class (grades 5-8). Children should begin returning home between 11:30am-12:00pm.

Make sure there is an adult at home to get the children off the van so the driver does not need to return the child to the church.

Church Van Conduct Policy

Transportation to and from church events is a privilege that is extended to children/youth in the Williams Valley area. Children/youth are expected to conduct themselves in a manner that does not interfere with the safe operation of the church vans.

Disciplinary infractions on the church van includes, but are not limited to:

1. Not following the directions of the van driver.
2. Not remaining in the seat and facing front when the van is in motion.
3. Littering or throwing items out the window or in the van. (paper, candy, cans, bottles, etc.)
4. Fighting, pushing, tripping, shoving, and kicking.
5. Yelling, making unnecessary noise, arguing with the van driver or helper.
6. Eating or drinking on the van.
7. Use of inappropriate language (profanity)
8. Destruction of property.

If a child/youth does not obey the van rules, a report will be filled out by the van driver and given to the person in charge of the program. The van misconduct will be investigated. Parents/guardians will be contacted to be informed what occurred on the van. Consequences will reflect the nature of the offense and frequency of misconduct. Significant and /or repeated van misconduct may result in loss of van privileges.

Due to the severity of the misconduct, and if the van returns to the church before the children/youth or taken home, the parents/guardians will be called to come and pick up the child/youth.
